### **Eligibility Criteria for Participation in tender & Information to Bidders.**

1. The intending bidders should have successfully completed at least one contract of Similar Nature of Work of at least **40%** value of the proposed contract within last 5 years from the date of publication of the notice. Such work executed should be in the Government Sector, Zilla Parishad , Public Sector undertaking. Dully signed Credential/Payment issued by competent authority not below the rank of **the District / Executive Engineer or District Level Officer.**
2. **The Bidders should submit Income Tax Return (Last 3 year ), Pan Card, GST, Professional Tax Clearance Certificate, Valid Trade licence must be uploaded in appropriate folder.** During scrutiny of Technical Bid/Tender document if it is found that any information is incorrect the technical bid/tender documents will be rejected without assigning any reason thereof. The Tender Committee of Alipurduar Zilla Parishad will have sole discretion to decide the eligibility of the Contractors on the basis of his submitted documents and reserves the right to reject the Bidder without assigning any reason thereof and the decision of the Alipurduar Zilla Parishad Authority will be final in this respect. All papers will be verified with original papers as and when required.
3. The prime contractor should have necessary bid capacity to execute the work (Documentary evidence in proof of the above should be enclosed).
4. ***For all bidders required to submit the soft copy (Scanned PDF File) of requisite EMD using the online payments mode. Accordingly, the net banking option shall have to be availed with any of the Banks listed in the ICCI Bank Payment gateway & the option of RTGS/NEFT through Bank A/C in any bank have to procure with the payment gateway of ICICI Bank by the e-procurement portal through web services. As qualification documents, the EMD amount paid by the bidder will get credited to the respective pooling A/C maintained by the Focal point Branch of ICICI Bank vide order no 3975-F(Y) dt 28-07-2016 of Govt of West Bengal.***
5. The indenting bidders should know the fact 'that the rates in the BOQs are **inclusive** all duties, taxes, royalties, cess, Deduction of Income tax, GST, Construction Workers' Welfare Cess, P.Tax etc. Deductions will be made at Source from the running bills in accordance with the existing rules/orders. No separate claim in any circumstances will be allowed.
6. In this tender no arbitration will be allowed.
7. All the related documents are to be produced **IN ORIGINAL** to this office as and when asked for.
8. No Mobilization/Secured advance will be allowed.
9. Running payment for work will be made to the agency **as per availability of fund** and as per norms
10. The bidders at their own responsibility and risk is encouraged **to visit and examine the site of works** and its surrounding and obtain all information that may be necessary for preparation of the bid and entering into contract for the work mentioned in the Notice. The Cost of visiting the site shall be at bidder own expense.
11. Alipurduar Zilla Parishad authority reserves the right to reject any or tender **without assigning any reason** thereof. It is also to be mentioned that if any bidder have found participating tender with false or forged documents necessary penal action will taken against them.

- xiv. The intending bidder have to submit have to submit Average Annual Turnover for the last 3 (Three) Financial Years from engineering construction works and to be supported by the documents. **(Form-III)**
  - a) 60% of amount put to bid, in case the amount put to bid is Rs.200 lakhs and less.

- b) 75% of amount put to bid, in case the amount put to bid is more than Rs. 200 lakhs.

**Terms and Conditions:**

1. This Notice Inviting Tender will be treated as part of the Tender Document.
2. "In case of any day" meant for this tender, appears to be an unscheduled holiday, the next working day will be treated as scheduled / prescribed day for the same purpose.
3. No material, Tools & Plants etc. will be issued by Alipurduar Zilla Parishad.
4. No preconditioned tender will be accepted.
5. All the rates of works are inclusive of all taxes, cess, levy, octroi, royalties, transportation, etc including all other incidental charges therein.
6. The Contractor, whose tender is accepted shall within 15 (fifteen) days of issue of an intimation to that effect by this office obtain additional one set of contract documents and submit the same duly signed by him to this office for formal agreement. If the contractor fails to perform the formalities as mentioned within the specified period, acceptance of the tender will be liable to be cancelled and the earnest money will be forfeited.
7. **The Successful Tenderer, herein after called the Contractor, will have to execute an agreement on a Non Judicial Stamp worth Rs. 100/- only.**
8. Time & Cost over-run will not be permitted. In case of any work not being completed by the contractor within the stipulated time-frame, necessary Penal Measure, in the tune of deduction of an amount, as decided by the **Artha-Sanstha-Unnayan-O-Parikalpana Sthayee Samity of Alipurduar Zilla Parishad**, will be imposed.
9. Necessary deduction towards, Income Tax and Welfare Cess etc. will be made as per Govt. norms. The Earnest Money will form the Security Deposit. The Earnest Money deposited by the unsuccessful bidders will be returned in due course.
10. Additional Performance security should be submitted @ 10 % of Amount Put to tender amount by the successful bidder if the accepted bid is 80 % or less of the tendered amount. The Additional Performance Security shall be submitted by in form of Bank Guarantee/ Fixed Deposit. This will be valid up to end of the contract period and will be renewed accordingly if required.
11. MGNREGA job card holders for unskilled portion of the works to the maximum possible extent should be engaged.
12. **The ALIPURDUAR ZILLA PARISHAD AUTHORITY reserves the right not to allow the agency to participate in future tenders under the following circumstances.**
  - i) Delay in completion of job.
  - ii) Poor performance in terms of quality of materials and workmanship
13. **Termination of Contract/ Work Order :**

The authority may terminate the contract/work order due to the following reasons.

  1. Poor Progress of work.
  2. Poor Quality of work.
  3. Adoption of any unfair means during execution of work.
  4. Violation/Non-compliance of any instructions of the authority.

For termination of the contract/work, the authority will issue a 7 days' notice to the agency/contract to make up the discrepancy/shortfall of the work as instructed by the authority, failing which the contract/work order will be terminated with forfeiture of E.M.D., S.D., Performance Security etc
14. **Discretion of the authority inviting tender:** The tender inviting authority reserves the right to accept or to reject any or all applications/tenders without assigning any reason whatsoever. On matters of dispute authority decision shall be final and binding. The quantity of work indicated in BOQ is provisional and should not be taken as firm. The extent to which the work would be actually executed will depend on the final decision of the District Engineer, Alipurduar Zilla Parishad. He however reserves the right to reduce the quantity even substantially without assigning any reason thereof and take up the same otherwise for which no compensation is payable under any circumstances
15. The successful contractor shall have to submit 3 (three) copies of application in the prescribed form for license (Form No VI) duly filled and signed by the contractor along with the tender. The license fee in terms of Rule – 26(2) and the Security Deposit of Labour in terms of Rule – 24 of West Bengal Contract & Labour (Regulation & Abolition) Act, 1972 should be separately deposited to the Local Treasury under the Head of Account - : 843 Civil Deposit – Deposit under various central and State Acts deposit under the contract Labour (Regulation and Abolition) Act, 1970.
16. Price Escalation claimed by the Agency will not be entertained by the Authority.

**17. Work Execution:**

- I) The successful Tenderer shall have to start the work at site within 7 days after receipt of the work order failing which work order shall be cancelled with forfeiture of earnest money deposited with ALIPURDUAR ZILLA PARISHAD without assigning any reason.
- II) After receipt of the Work Order, the successful Tenderer shall submit the work programme, Bar chart of execution of the work, establish site office and deploy Site Engineers. He shall also maintain Work Order Copy, Drawings, schedule of work and tools & tackles at site to assist Engineers to carry out necessary checking and supervision of the work
- III) **Sub-letting** of the job is not permissible and the Tenderer must submit one undertaking that he will not sub-let the job under any circumstances. If the authority comes to know that the agency has sub-let the work then action shall be taken to terminate the contract and the SD money will be forfeited and in addition the contractor shall not be entitled to recover or be paid for any work there for actually performed under the contract.
- IV) All materials & workmanship shall be as per the approved quality and methodology.
- V)** Agency should possess the requisite and relevant equipment's and machineries for the work. If equipment's and machineries are not deployed as per the undertaking given by the contractor, the Engineer in charge is authorized to stop the work and direct the contractor to deploy them immediately. If the contractor fails to carry out the direction, then the authority may take appropriate action including forfeiture of Earnest Money Deposit ( EMD ) and cancellation of the work order.
- VI) The contractor shall collect **photography/video photography** of the site firstly before the start of the work, secondly mid-way in the execution of different stages of work and lastly after the completion of the work. The photographs shall have digital date printed over it. A minimum of **10 such** photographs should be submitted at the time of submission of claim for payment. No separate payment will be made to the contractor for this purpose. Payment shall not be made without submitting the photographs/video photographs. Some photographs will have engineers inspecting the site, machinery working, measurement etc.
- VII)** All other clause(s) applicable as per W.B. Form No. 2911 (Standard bid document)

18. Any Typographical mistake in case of unit, Rate, Quantity, Amount, any type of nomenclature in items of works/items itself including description etc. whatsoever as stated in BOQ, That can't be claimed during agreement or so. In that case sanctioned estimate will be binding criteria.

**19. DEFECT LIABILITY PERIOD:-** The Defect Liability period will be decided as per nature of work.

- a) The work of patch repair or patch maintenance in nature or a combination thereof, the Defect Liability Period of the work shall be **three months** from the actual date of completion of the work.
- b) Thorough Bituminous Surfacing work with bituminous thickness less than 40 mm, Repair & Rehabilitation of any road/ bridge/ culvert/ building/ Sanitary & Plumbing work, the Defect Liability Period of the work shall be **one year** from the actual date of completion of the work.
- c) Extension of building/ bridge/ culvert, Construction of new flexible pavement up to bituminous level which has been designed for a period of 3 years or more, Widening and strengthening of flexible pavement designed for a period of 3 years or more, Improvement of riding quality/ Strengthening of flexible pavement designed for a period of 3 years or more; Providing only mastic asphalt layer over existing bituminous surface without providing bituminous profile corrective course/ bituminous base course, the Defect Liability Period of the work shall be **three years** from the actual date of completion of the work.
- d) Construction of new building/ new bridge/ new culvert, Reconstruction of building/ bridge/ culvert including construction of approach roads for bridge/ culvert, Construction of rigid pavement, Reconstruction of rigid pavement, Construction of new flexible pavement covered by mastic work which has been designed for a period of 5 years or more, Widening and strengthening of flexible pavement covered by mastic work which has been designed for a period of 5 years or more, Improvement of riding quality/ Strengthening of flexible pavement covered by mastic work which has been designed for a period of 5 years or more, the Defect Liability Period of the work shall be **five years** from the actual date of completion of the work.
